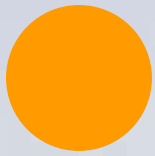

Peer Reviews

- **Community level workshops** within the city where the results of the local assessments (milestone 1) are discussed by the City stakeholders
- **Report tabled before the local Council** for debate and further discussion
- **National Workshops** - elected leaders of different cities to meet and share best practices from their cities
 - Cities will present a priority area for action at the national workshop
 - a commitment to action and to reporting on progress at the next national meeting



Milestone 1- Inventory of water consumption and water quality management data.

The report should identify the following:

- baseline water consumption data
- water quality protection baseline
- available policies and practices in local water resources management
- gaps in policies, operations and services
- priority areas for action
- areas of excellence or best practices
- stakeholders involvement in decision making processes

Milestone 2 - Setting goals for water conservation and water quality.

Establish targets for water use and quality:

- For the municipality
(Corporate goals)
- For the community
(Community goals)

Outline the strategy Council will undertake to reach the target goals

- **Consider how to incorporate the strategy within existing programmes of Council**
- **Develop a detailed implementation plan that includes budget, resources, timelines and priorities**



Milestone 4 - Implementation and measurement of the Local Water Action Plan.

- **Quantification of actions implemented including budget, resources and water quality improvements and water consumption savings**



Milestone 5 - Monitor, review and report on implemented actions.

- **report and monitor processes that will provide the data and information you need to review water campaign appropriately**
- **Report results back to council and the community on an ongoing basis**
